INVITATION TO BID FOR:

Item A: One (1) Unit Brand New Jogger

Item B: One (1) Unit Brand New Pile Hoist

Item C: One (1) Unit Brand New Single Head Free Standing Stitching Machine

Item D: One (1) Unit Brand New Perforating Machine

1. The *Philippine Charity Sweepstakes Office (PCSO)*, through the *PCSO Corporate Budget* intends to apply the sum of: *One Million Nine Hundred Forty Thousand Pesos (P1,940,000.00)* being the Approved Budget for the Contract (ABC) for Item A: *One (1) unit Brand New Jogger*, *One Million Two Hundred Three Thousand Pesos (P1,203,000.00)* for Item B: *One (1) unit Brand New Pile Hoist*, *One Million One Hundred Seventy Seven Thousand Pesos (P1,177,000.00)* for Item C: *One (1) unit Brand New Single Head Free Standing Stitching Machine*; and *Three Million Forty Thousand Nine Hundred Forty Pesos (P3,040,940.00)* for Item D: *One (1) unit Brand New Perforating Machine*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *PCSO* now invites bids for the above items. Delivery of the Goods (per item) is required *within one hundred twenty (120) days*. Bidders should have completed, within *the last ten (10) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
4. Interested bidders may obtain further information from *PCSO Bids and Awards Committee* and inspect the Bidding Documents at the address given below from *8:00am to 5:00pm*.

A complete set of Bidding Documents for each item may be acquired by interested Bidders on *February 29, 2016 (Monday) up to 8:30am of March 21, 2016 (Monday)* from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *Ten Thousand Pesos (P10,000.00) per set, per item*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

5. The PCSO will hold a Pre-Bid Conference for Items A to D on *March 7, 2016 (Monday)* at *1:30pm*, BAC Room, 3/F Conservatory Building, 605 Shaw Blvd., Mandaluyong City, which shall be open to all interested parties.
6. Bids for Items A to D must be delivered to the address below on or before *10:00am of March 21, 2016 (Monday)*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening for Items A to D shall be on *March 21, 2016 (Monday)* at *10:30am* at BAC Room, 3/F Conservatory Building, 605 Shaw Blvd., Mandaluyong City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. The PCSO reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
