INVITATION TO RE-BID

Construction of 3-Storey PCSO Cavite Branch Office Building in Bacoor City, Cavite	7,750,000.00

1. The Philippine Charity Sweepstakes Office (PCSO), through its Corporate Operating Budget for 2017, intends to apply the sum of **Seven Million Seven Hundred Fifty Thousand (Php 7,750,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Construction of 3-Storey PCSO Cavite Branch Office Building- Contract No. 03- 2017 (INFRA)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PCSO now invites bids for the Re-bidding of Construction of a 3-Storey PCSO Cavite Branch Office Building. The Completion of the Works is required within **Nine (9) Months from Notice to Proceed (NTP)**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from the PCSO Special Bids and Awards Committee II and inspect the Bidding Documents at the address given below from 8:00am – 5:00pm.
5. A complete set of Bidding Documents may be acquired by interested bidders on **September 25, 2017 (Monday) up to 8:30am of October 16, 2017**

(Monday) from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand Pesos (Php 10,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The PCSO will hold a Pre-Bid Conference on **October 03, 2017 (Tuesday)** at 1:30pm, Bids and Awards Committee (BAC) Office, 3rd Floor, Conservatory Building 605 Shaw Boulevard, Mandaluyong City, which shall be open to prospective bidders.
7. Bids must be duly received by the SBAC II Secretariat at the address below on or before **9:00am, October 16, 2017 (Monday)**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **9:30am, October 16, 2017 (Monday)**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The PCSO reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
