

SUPPLEMENTAL MEMORANDUM OF AGREEMENT

(For the Supply & Delivery of Item B: One (1) Unit Brand New Pile Hoist)

THE PUBLIC IS INFORMED:

This AGREEMENT is executed between:

PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO), a government-owned and controlled corporation, existing by virtue of Republic Act No. 1169, as amended by Batas Pambansa Blg. 42, holding office at 4th Floor Sun Plaza Building, 1507 Shaw Boulevard corner Princeton Street, Mandaluyong City, represented by its General Manager, **ATTY. JOSE FERDINAND M. ROJAS II**, authorized for this purpose under PCSO Board Resolution No. 211, Series of 2016, as contained in Secretary's Certificate notarized on June 6, 2016, a copy of which is attached as **Annex "A"**;

-and-

CALEDONIAN INTERNATIONAL CORPORATION (CALEDONIAN), a duly organized and existing corporation under the laws of the Republic of the Philippines, with principal office address at Caledonian Building, 4384 Montojo Street, Brgy. Tejeros, 1204 Makati City, represented by **REUBEN A. NAGTALON**, in his capacity as Vice President, authorized for this purpose as shown in Secretary's Certificate notarized on March 16, 2016, a copy of which is attached as **Annex "B"**.

ANTECEDENTS:

After the conduct of a public bidding for the supply and delivery of one (1) unit brand new Pile Hoist, the Bids and Awards Committee, in its Resolution No. 20-B, Series of 2016 declared the bid of Caledonian as the Single Calculated Responsive Bid (SCRB) and recommended award of the contract to Caledonian for a contract price of One Million One Hundred Ninety-Nine Thousand Pesos (Php 1,199,000.00).

In its Resolution No. 211, Series of 2016, the PCSO Board of Directors confirmed BAC Resolution No. 20-B, Series of 2016 and approved the award of the Contract to Caledonian.

Accordingly, PCSO and CALEDONIAN have agreed as follows:

1. The words and expressions shall have the same meanings as are respectively assigned to them in the General and Special Conditions of Contract.
2. The following documents, including all bid documents, shall form integral parts of this contract:
 - a. the Bid Form and the Price Schedule submitted by the Bidder (**Annex "C"**);
 - b. the General Conditions of Contract (**Annex "D"**);
 - c. the Special Conditions of Contract (**Annex "E"**);
 - d. the Schedule of Requirements (**Annex "F"**);
 - e. the Technical Specifications (**Annex "G"**);
 - f. the PCSO's Notification of Award (**Annex "H"**);
 - g. the Performance Bond posted by Caledonian International Corporation (**Annex "I"**); and
 - h. the Notice to Proceed (**Annex "J"**).
