**BAC RESOLUTION NO. 019  
Series of 2015**

**WHEREAS**, on February 24, 2015, the Bids and Awards Committee (BAC) discussed the Memorandum of the Technical Working Group (TWG) for ITSD Concerns dated February 12, 2015 (copy attached) relaying the result of the post-qualification conducted on Accent Micro Technologies, Inc. (AMTI) for One (1) Lot ITSD Transfer Project;

**WHEREAS**, as stated in its February 12, 2015 report, the TWG certified that they were able to verify the submission of AMTI particularly the certificates during the said post-qualification. They found AMTI's submission as compliant with the Technical Specifications of the Office. The BAC adopted the position of the TWG and rated the bid of AMTI as "PASSED" and declared it as the Bidder with the Lowest Calculated and Responsive Bid (LCRB), subject to the approval of the PCSO Board of Directors;

**WHEREFORE**, the BAC resolved, as it hereby resolves, to recommend the approval of the following:

1. Declaration of Accent Micro Technologies, Inc. as the Bidder with the Lowest Calculated and Responsive Bid (LCRB) for One (1) Lot ITSD Transfer Project consisting of (A) Data Center Transfer, (B) Enterprise Wireless Network, (C) Data Center Facilities; and
2. Award the contract for One (1) Lot ITSD Transfer Project consisting of (A) Data Center Transfer, (B) Enterprise Wireless Network, (C) Data Center Facilities to **Accent Micro Technologies, Inc.** for a contract price of **Twenty Eight Million Eight Hundred Ninety Seven Thousand Six Hundred Seventy Five Pesos and 88/100 (P 28,897,675.88)**.

Subject to the approval by the Acting Chairman and General Manager Jose Ferdinand M. Rojas II and confirmation by the PCSO Board of Directors.

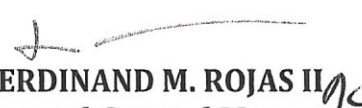
